WHAT IS AFTER PROM?

WHO: All Grafton High School (GHS) seniors and their guests are welcome to attend the After Prom Celebration of Life whether they attend the Prom or not.

WHAT: This year's theme is **KEEP CALM AND SAIL ON**. This will be an evening packed with entertainment, activities, food, fun, and lots of prizes.

WHEN: Prom is Saturday, June 1, 2019, with After Prom beginning immediately afterwards on Sunday, June 2, 2019, from midnight until 4:00 am.

WHERE: After Prom will be held at the **Peninsula Metropolitan YMCA (aka Victory Family YMCA)**, located at 101 Long Green Blvd. in Yorktown.

WHY: To provide a safe and substance free environment for our teenagers AFTER Prom night.

HOW: This event is sponsored by GHS PTSA volunteers, and is funded through fundraising efforts, and generous donation from parents, families, businesses, and community members.

WHY IS IT IMPORTANT?

After Prom saves lives! After Prom is an all-night supervised event that allows our teenagers to relax and have fun in a safe, chemical-free, and entertaining environment. Tragedies occur each year as teenagers face the busy prom evening subject to exhaustion, harmful substances and potential driving hazards. For this reason, we invite and encourage all GHS Seniors to attend this safe and enjoyable evening celebration, away from the dangers of drugs, alcohol, and other detrimental threats.

ADMISSION POLICIES

All participants (GHS) Seniors/Guests), REGARDLESS OF THEIR AGE must return a registration form and waiver agreement signed by his/her parent/legal guardian in order to purchase tickets and attend AFTER PROM. We appreciate your full cooperation in this matter

1. **Tickets are 10 dollars per person. They are ONLY sold in advance. Tickets will NOT be SOLD at the door.** Tickets go on Sale May 13th-17th in the senior atrium during lunch blocks and are NON-REFUNDABLE. No additional cash will be needed at the event. Everything is included (food, games, activities, prizes). **TICKETS WILL NOT BE SOLD AT THE DOOR.**
2. To register, GHS Seniors MUST bring the following with them in order to buy tickets:
 - a. **The EVENT REGISTRATION PACKET** (GHS seniors and Guests) completed and signed by both participant AND his/her parent/legal guardian.
 - b. **ALL "Assumption of Risk and Release Waiver of Liability Agreements"** (PTSA, YMCA, Spacewalk of Yorktown, Amazing Entertainment), completed and signed by both participant and parent/legal guardian.
 - c. Cash or check (**payable to GHS PTSA**) \$10.00/GHS Senior; \$20 if bringing a guest.
3. Each GHS senior is permitted only one guest for PROM and AFTER PROM. If you take a guest to the PROM, and want to take a guest to AFTER PROM, it must be the same person.

4. GHS Seniors/Guests and Parents/Guardians are responsible for transportation to and from event.
5. ALL participants (GHS Seniors/Guests) are required to bring a form of a picture ID to enter the facility. A driver's license or student I.D. will be acceptable.
6. All personal items MUST be checked at designated area which will be supervised for the duration of the event. GHS Seniors and guests will have access but will not be able to remove items away from designated area.
7. Guests may participate in all activities, but Door prizes and Grand prizes are for **GHS SENIORS ONLY**.
8. Parents and guardians will be notified via phone call of late arrival and early departure. IF a GHS senior decides to leave early, they cannot leave without their guest and also a phone call to their parents/guardians will be expected. We cannot accept TEXT MESSAGES as form of communication for late arrival or early departure.
9. The YMCA prohibits black sole shoes in their facility. Sneakers must be worn to participate on the Rock Wall activity. We suggest changing into casual clothes before arriving at After Prom.
10. NO OUTSIDE FOOD OR DRINK WILL BE ALLOWED IN THE YMCA. DRUGS AND ALCOHOL PROHIBITED. Bags will be checked.

Assumption of Risk and Waiver of Liability Agreement

THIS IS A RELEASE OF LEGAL RIGHTS — READ CAREFULLY AND UNDERSTAND FULLY BEFORE SIGNING.

MUST BE SIGNED BY ALL ATTENDEES AND PARENT/GUARDIANS

I, the undersigned Parent/Legal Guardian (hereinafter referred to as “Parent”), grant permission for my child (the “Participant”) to attend the **Grafton High School Parent-Teacher-Student Association (GHS PTSA) After Prom** event (the “Event”) being held at the **Peninsula Metropolitan YMCA (YMCA) on Sunday, June 2, 2019 from 12:00 AM (MIDNIGHT) to 4:00 AM.**

We, the undersigned Participant and Parent, enter freely and voluntarily into this ASSUMPTION OF RISK AND WAIVER AND RELEASE OF LIABILITY AGREEMENT (the “Agreement”), and understand that this legally binding agreement will be used by the **GHS PTSA** and their respective holders, sponsors (including the County School Board or York County, VA), organizers, members, officers, successors, assigns, volunteers, employees, and agents (hereinafter, collectively denoted as the “Released Parties”). We acknowledge that this Agreement will govern the Participant’s actions and responsibilities at the Event, including the Participant’s travel to and from the Event, and that this Agreement between the Participant, Parent and the Released Parties supersedes all prior agreements, terms, understandings, conditions, representations and warranties, whether written or oral.

Severability

Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

Safety and Health Release

We, the undersigned Participant and Parent, understand that the YMCA requires strict adherence to its standards of safety and conduct and agree that Participant will fully abide by all standards, policies, rules, and regulations. The Participant shall not engage in inappropriate conduct including the use of physical or verbal violence. We certify that the Participant is physically fit to participate in the Event; and has not been advised to not participate by a qualified medical professional. We further certify that there are no health-related reasons or problems which preclude participating in this Event. We hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during the Event. If medical treatment or hospitalization is required, we agree to pay all medical and hospital bills relating thereto, permanent or partial disability, or death, and damages to the Participant caused by and arising from participating in the event.

Media Release

We, the undersigned Participant and Parent, understand that participants may be photographed at this event, and hereby agree to allow the Participant’s photo, video or film likeness to be used for any legitimate purpose by the event holders, organizers, representatives and assigns without compensation from GHS and PTSA.

Assumption of Risk

We, the undersigned Participant and Parent, are aware that the Event will include, but is not limited to, the following activities: large inflatable games, casino games, slot machines, rock wall, gym/sports activities, raffle prizes, contests, dancing, and great food. We acknowledge that the Participant and Parent have been made aware and fully understand that although the facilities, equipment, services, and activities are designed to provide a safe level of exercise, activity, recreation and enjoyment, there are inherent risks which are beyond the control of the Released Parties. These risks may include but are not limited to: loss or damage to personal property, illness, personal injury, death, and/or risks that may arise from ordinary negligence or carelessness on the part of the Released Parties, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without a finding of fault.

We, the undersigned Participant and Parent, agree that the Participant is responsible for his/her actions and further recognize, understand and agree that the Released Parties assume no responsibility for any liability, damage or injury that may be caused by Participant’s negligence or willful acts committed prior to, during or after participation in the Event, or for any liability, damage or injury caused by the intentional or negligent actions or inactions of any other participant in the Event, or caused by any other person. As such, WE, THE PARTICIPANT AND PARENT, HEREBY KNOWINGLY AND VOLUNTARILY ASSUME RESPONSIBILITY FOR ANY AND ALL RISK of accident, injury, illness, or damage to or loss of property on behalf of the Participant.

Waiver and Release of Claims

IN CONSIDERATION FOR allowing the Participant to: (a) attend and participate in activities at the **GHS PTSA** After Prom Event, (b) utilize the facilities and equipment at the **YMCA** as listed above the undersigned, do hereby agree, on behalf of representatives, insurer, assigns, and attorney as follows:

- (1) WAIVE, RELINGUISH, RELEASE, AND FOREVER DISCHARGE any and all rights, liability, claims, demands, and actions for damages that the Participant may have, or that may hereafter accrue to Participant as a result of attending the Event, including but not limited to, bodily injury or disability, mental injury, disability, death, economic loss, or any damage to the Participant resulting from any negligent act or omission by the Released Parties. Participant further releases and discharges the Released Parties from liability for any accident, illness, injury, loss or damage to personal property, or any other consequences arising or resulting directly or indirectly from Participant's participation in the Event. The Participant acknowledges and agrees that the Released Parties assume no responsibility for any liability, damage, or injury that may be caused by Participant's negligent or intentional acts or omissions committed prior to, during, or after participation in the Event, or for any liability, damage, or injury caused by the intentional or negligent acts or omissions of any other participant in the Event, or caused by any other person.

- (2) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the Released Parties mentioned in this agreement from any and all liabilities or claims, causes of action, obligations, lawsuits, charges, complaints, contracts, controversies, covenants, agreements, promises, damages, costs, expenses, responsibilities, of whatsoever kind, nature or description, whether, direct or indirect, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, whether caused by the negligence of release or otherwise that arise from participating in the Event.

This AGREEMENT is legally binding and shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
